COPYRIGHT PROVISIONS OF NC CIGRE KO

These provisions regulate the procedure and requirements for publication of papers or articles to be submitted to the NC CIGRE KO for publication. The form on the back of the list regulating the adoption for publication of papers and the transfer of copyright shall be completed and returned to the NC CIGRE KO.

1. The policy of NC CIGRE is to have the copyright for a technical contribution published in the interest of NC CIGRE KO, its authors and their employers and to facilitate the proper use of these materials by others.
2. NC CIGRE KO publishes and distributes the papers within the country. When a paper is submitted to NC CIGRE KO for publication, its acceptance automatically implies that NC CIGRE KO has all rights related to them, in accordance with the law and these provisions.
3. NC CIGRE KO applies the following policies for the submitted papers: NC CIGRE KO shall provide the presentation and display of papers within the Conference, their publication, as well as the access of users to these papers, as an activity of NC CIGRE KO. If the consent is necessary for publication of submitted papers, the author is responsible to give it, not the NC CIGRE KO.
4. If the copyright to present the paper belongs to the author (s), then the publication consent must be signed by the author (s) in the form under subheading A, at the same time writing down the date.
5. If the author belongs to an organization, employed in it or it is a work related to the activity of that organization, then the publication consent must be signed by a representative of the organization in the form under subheading B, at the same time writing down the date.
6. The author (s) and/ or organization giving consent for transferring of copyright shall have the following competencies:
 - Holding all property rights other than copyrights, such as patent rights;
 - Reproducing images and performances of the paper with the prior and timely notification of the Secretariat of NC CIGRE KO.
 - Reusing the whole or a part of the paper for the purpose of compiling other papers;
 - Copying published papers, free of charge, for their needs but not for sale, provided that they are not called on behalf of NC CIGRE KO that may suggest the promotion of certain products, services or producers under the symbol and NC CIGRE KO.
7. If the paper is refused, then the copyrights of the paper remain to the original author (s). If the paper is accepted but not published within a reasonable time after the acceptance, then the author (s) has (have) the right to request that NC CIGRE KO returns the copyright to the original author (s).
